Summary of Upcoming Construction Events

How Will My Services Be Affected?

April 9 to April 13, 2018

The following is a summary of the work proposed for the week of Monday, April 30 to Friday, May 4, 2018.

Please note that lane closures and/or restrictions are expected to occur daily causing significant traffic delays and congestion. **Motorists and pedestrians are strongly encouraged to use the detour (D1).**

Location No. 1: River Road West & Veterans Way

Scope of Work:

Installation of the proposed storm sewer on River Road West through the intersection of Veterans Way.

Impacts:

Temporary lane closures to allow for the installation of the Veteran Way storm sewer crossing in a safe and efficient manner, therefore traffic delays are expected. OPP will be on-site to monitor and direct traffic through the intersection.

Location No. 2: River Road West and Fernbrook Drive

Scope of Work:

Relocation of utilities on the south side of River Road West between Fernbrook Drive and Smallman Drive to allow for the installation of the proposed storm sewer.

Impacts:

Temporary lane reductions to allow for the utility relocate to be completed.

Location No. 3: River Road West and Innisbrook Drive

Scope of Work:

Installation of the proposed storm sewer on River Road West in the vicinity of Innisbrook Drive.

Impacts:

Temporary lane closures to allow for the installation of the storm sewer.

How will Access to my Property be Affected?

Unobstructed pedestrian access to all dwellings and businesses will be maintained. Where work is located within driveways or entrances to dwellings and/or businesses, temporary access will be provided. Full access will be restored as quickly as possible after the full work is completed.

Primrose Contracting will give prior notice of any access restrictions to the residents and businesses. We ask for your patience in such instances. Access for emergency vehicles will be maintained at all times.

Special Needs

If you require wheelchair access or other special needs, please contact the Project Manager or Construction Inspector.

Telephone, hydro, cable TV, sewer and gas services should not be affected by the construction, barring any unforeseen circumstances. Unplanned interruptions to your services may occur. Your patience during these times is appreciated. The Contractor is committed to restore the services as quickly as possible.

Water service will be affected for short periods of time when new water services are installed. You will be notified in advance as to when to expect these planned interruptions to your water supply.

The Contractor will collect garbage and recycling containers, as required for pickup and return the containers to individual properties on each garbage day while the construction operations interfere with regular garbage/recycling pickup. *Please be sure to clearly label your containers so that they can be returned.*

Safety

Primrose Contracting is required to conduct the work in a safe manner, including fencing of the work area, etc. We ask that you take extra caution during the construction period to ensure everyone's safety.

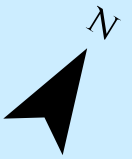

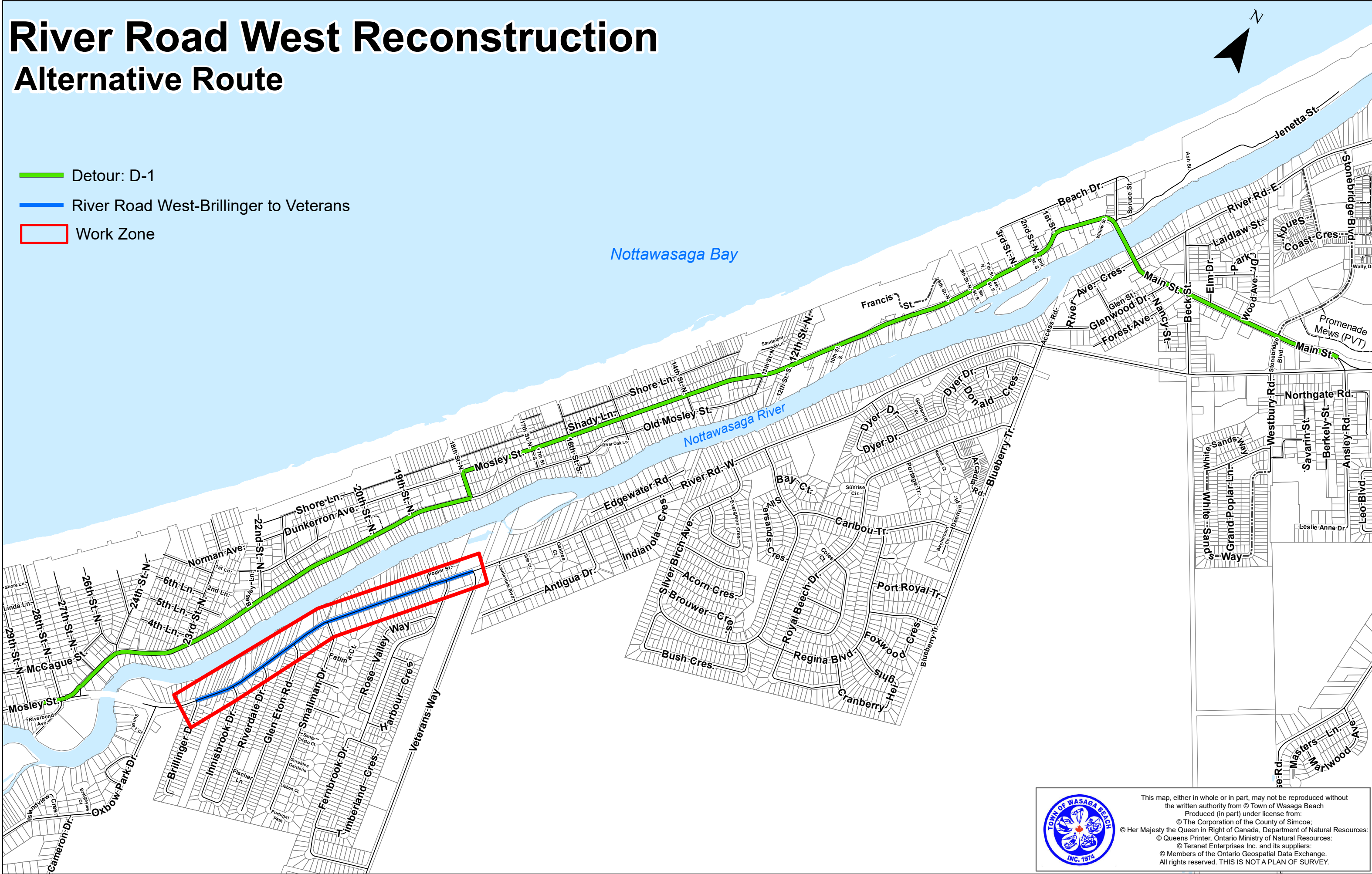
