Current Construction Events (September 18th to September 22nd)

The following is a brief summary of the ongoing work and map showing the general work area of the work zone:

Work completed to Date

Location: River Road West (RRW) & Veterans Way

Scope of Work: Installation of the Outlet Storm Sewer and Manholes within the easement north of RRW.

For the week of September 18 to September 22, Primrose Contracting Inc. is scheduled to complete the following work:

Upcoming Construction Events (September 18th to September 22nd)

Location: River Road West (RRW) & Veterans Way

Scope of Work: Installation of sewer crossing and maintenance holes on River Road West east of Veterans Way

Impacts: Lane closure to allow for the proposed RRW storm sewer crossing and installation of maintenance holes.

The general area of the work zone for the week of September 18th is shown below. A detour route as shown on the attached map will be signed to direct traffic around the work zone. **There will be major traffic delays so please use the detour!**



How will Access to my Property be Affected?

Primrose Contracting will maintain unobstructed pedestrian access to all dwellings and businesses. Where work is located within driveways or entrances to dwellings and/or businesses, temporary access will be provided. Full access will be restored as quickly as possible after the full work is completed.

Primrose Contracting will give prior notice of any access restrictions to the residents and businesses. We ask for your patience in such instances. Access for emergency vehicles will be maintained at all times.

Special Needs

If you require wheelchair access or other special needs, please contact the Project Manager or Construction Inspector.

How Will My Services Be Affected?

Telephone, hydro, cable TV, sewer and gas services should not be affected by the construction, barring any unforeseen circumstances. Unplanned interruptions to your services may occur. Your patience during these times is appreciated. The Contractor is committed to restore the services as quickly as possible.

Water service will be affected for short periods of time when new water services are installed. You will be notified in advance as to when to expect these planned interruptions to your water supply.

The Contractor will collect garbage and recycling containers, as required for pickup and return the containers to individual properties on each garbage day while the construction operations interfere with regular garbage/recycling pickup. **Please be sure to clearly label your containers so that they can be returned.**

Safety

Primrose Contracting is required to conduct the work in a safe manner, including fencing of the work area, etc. We ask that you take extra caution during the construction period to ensure everyone's safety.

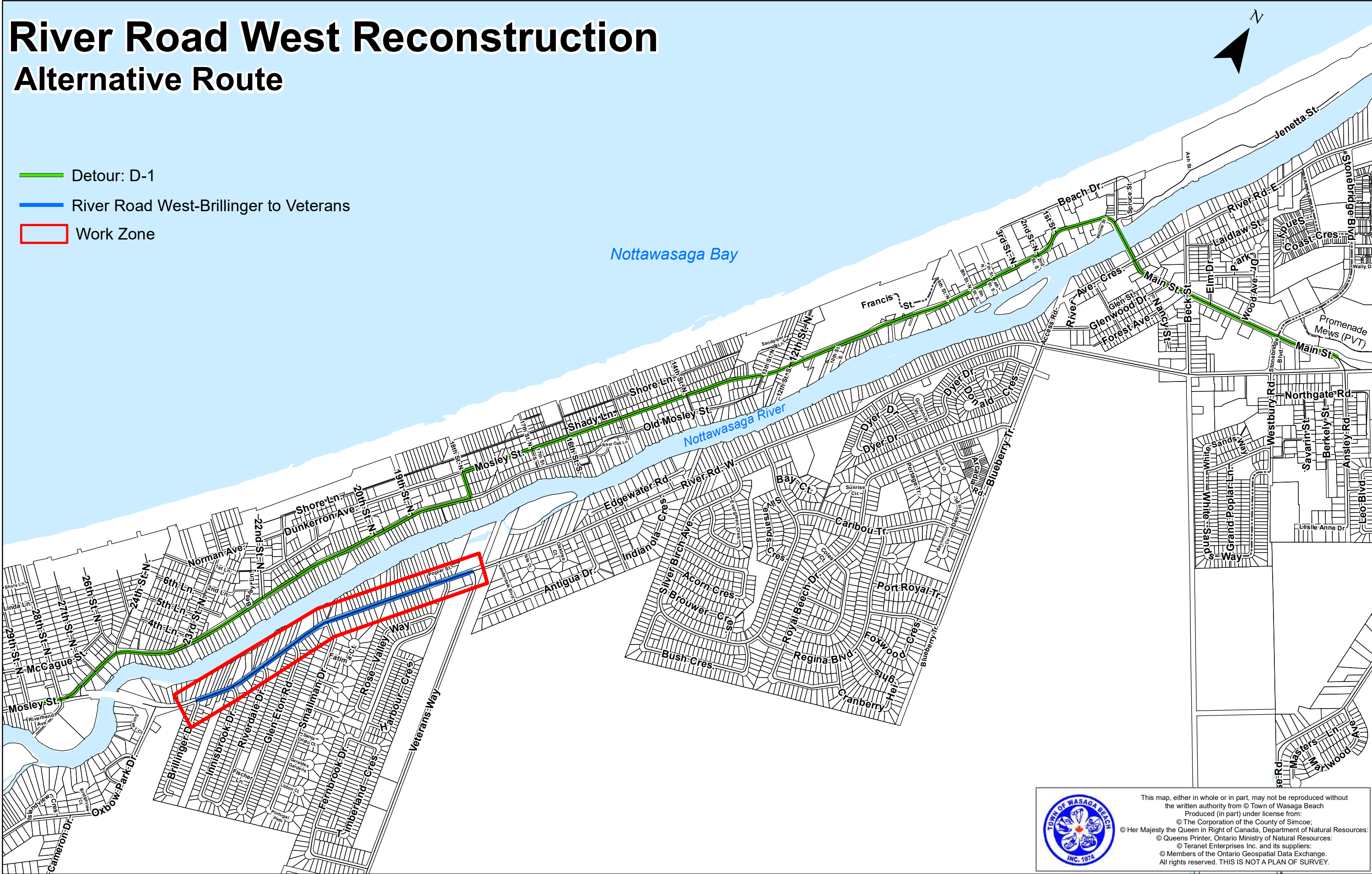
