Summary of Upcoming Construction Events

July 16 to July 20, 2018

The following is a summary of the work proposed for the week of Monday, July 16 to Friday, July 20, 2018.

Please note that lane closures and/or restrictions are expected to occur daily causing significant traffic delays and congestion.

The public is strongly encouraged to use the detour (D1) as the temporary lane closures to allow for the installation of the proposed infrastructure will result in delays.

Location No. 1: River Road West – Veteran Way to Smallman Drive

Scope of Work:

Road works which includes construction the road and the installation of the curb and sidewalk along River Road West between Fernrook Drive and Smallman Drive.

Location No. 2: River Road West and Smallman Drive Intersection

Scope of Work:

Installation of the proposed storm sewer at the intersection of River Road West and Smallman Drive.

Location No. 3: River Road West - Various Locations

Scope of Work:

Installation of the proposed catch basins and water services on the south side of River Road West

How will Access to my Property be Affected?

Unobstructed pedestrian access to all dwellings and businesses will be maintained. Where work is located within driveways or entrances to dwellings and/or businesses, temporary access will be provided. Full access will be restored as quickly as possible after the full work is completed.

Primrose Contracting will give prior notice of any access restrictions to the residents and businesses. We ask for your patience in such instances. Access for emergency vehicles will be maintained at all times.

Special Needs

If you require wheelchair access or other special needs, please contact the Project Manager or Construction Inspector.

How Will My Services Be Affected?

Telephone, hydro, cable TV, sewer and gas services should not be affected by the construction, barring any unforeseen circumstances. Unplanned interruptions to your services may occur. Your patience during these times is appreciated. The Contractor is committed to restore the services as quickly as possible.

Water service will be affected for short periods of time when new water services are installed. You will be notified in advance as to when to expect these planned interruptions to your water supply.

The Contractor will collect garbage and recycling containers, as required for pickup and return the containers to individual properties on each garbage day while the construction operations interfere with regular garbage/recycling pickup. *Please be sure to clearly label your containers so that they can be returned.*

Safety

Primrose Contracting is required to conduct the work in a safe manner, including fencing of the work area, etc. We ask that you take extra caution during the construction period to ensure everyone's safety.
