

River Road West Reconstruction Brillinger Drive to Veterans Way Construction Newsletter No.6

October 6, 2017

Current Construction Events (October 10th to October 13th)

The following is a brief summary of the ongoing work and map showing the general work area of the work zone:

Work completed to Date

Location: River Road West (RRW) & Veterans Way

Installation of dewatering so that the storm sewer installation at this intersection can be completed.

Upcoming Construction Events (October 2nd to October 6th)

Location No. 1: River Road West (RRW) & Veterans Way

Scope of Work:

Start dewatering pipes to allow for the sewer installation at the intersection of River Road West and Veterans Way.



Impacts: Temporary lane closures to allow for the installation of the storm sewer.

Location No. 2: River Road West (RRW) & Brillinger Drive

Scope of Work: Installation of the storm sewer on the south side of RRW moving east along RRW from Brillinger Drive.



Impacts: Temporary lane closures to allow for the installation of the proposed storm sewer.

How will Access to my Property be Affected?

Primrose Contracting will maintain unobstructed pedestrian access to all dwellings and businesses. Where work is located within driveways or entrances to dwellings and/or businesses, temporary access will be provided. Full access will be restored as quickly as possible after the full work is completed.

Primrose Contracting will give prior notice of any access restrictions to the residents and businesses. We ask for your patience in such instances. Access for emergency vehicles will be maintained at all times.

Special Needs

If you require wheelchair access or other special needs, please contact the Project Manager or Construction Inspector.

How Will My Services Be Affected?

Telephone, hydro, cable TV, sewer and gas services should not be affected by the construction, barring any unforeseen circumstances. Unplanned interruptions to your services may occur. Your patience during these times is appreciated. The Contractor is committed to restore the services as quickly as possible.

Water service will be affected for short periods of time when new water services are installed. You will be notified in advance as to when to expect these planned interruptions to your water supply.

The Contractor will collect garbage and recycling containers, as required for pickup and return the containers to individual properties on each garbage day while the construction operations interfere with regular garbage/recycling pickup. **Please be sure to clearly label your containers so that they can be returned.**

Safety

Primrose Contracting is required to conduct the work in a safe manner, including fencing of the work area, etc. We ask that you take extra caution during the construction period to ensure everyone's safety.
