IN THE MATTER OF Section 53 of the *Planning Act*, R.S.O. 1990, as amended.

LANDS SUBJECT TO THE APPLICATION: Lot J Plan 674, Part of Lot 6 Concession 16, located at 731 Mosley Street, Town of Wasaga Beach, County of Simcoe. Municipal water and sewer is available for the subject lands.

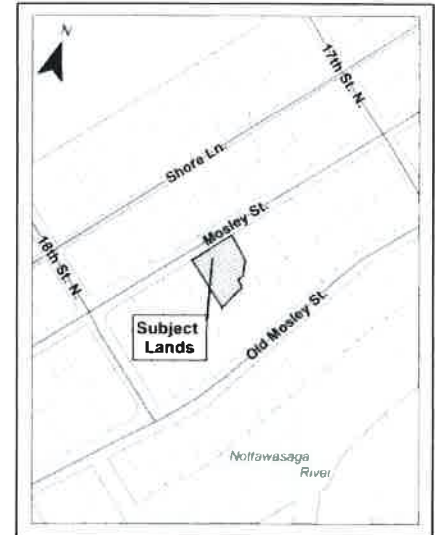
A KEY MAP showing the general location of the lands subject to the application is provided with this notice.

PURPOSE AND EFFECT: An application submitted by 2243344 Ontario Inc. c/o Edward Lee, owner of the subject land. The application proposes to create one residential building lot for a total of two lots.

The portion of the property proposed to be severed as shown on the survey provided (Part 1) has a frontage of approximately 14 metres (46 feet), an irregular depth and an area of approximately 466 square metres (5,016 square feet).

The portion of the property to be retained as shown on the survey provided (Part 2) has a frontage of 12 metres (40 feet), an irregular depth and an area of approximately 522 square metres (5,619 square feet).

OTHER APPLICATIONS: The land subject to this application for consent are currently the subject of conditionally approved consent file B19/18.



APPOINTMENT FOR HEARING: Monday, April 15, 2019 at 4:00 p.m. has been appointed by the Committee of Consent for the Town of Wasaga Beach for the purpose of a public hearing of all parties having an interest in this matter.
