



**TOWN OF WASAGA BEACH COMMITTEE OF CONSENT
NOTICE OF HEARING FILE NUMBER B07/19**

IN THE MATTER OF Section 53 of the *Planning Act*, R.S.O. 1990, as amended.

LANDS SUBJECT TO THE APPLICATION: Lot 10 to 12 Plan 752, located at 326 River Road East, Town of Wasaga Beach, County of Simcoe. Municipal water and sewer is available for the subject lands.

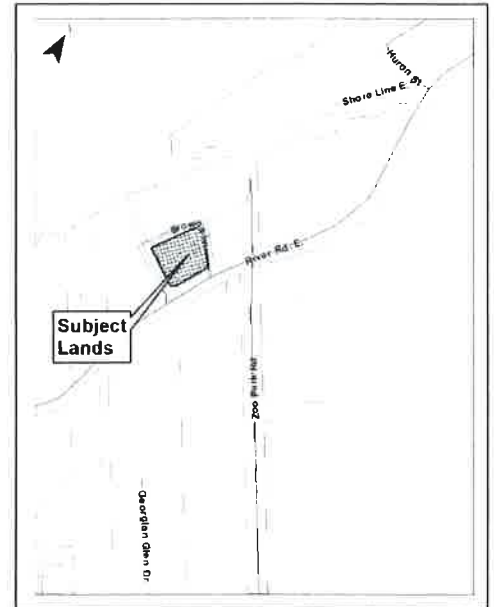
A KEY MAP showing the general location of the lands subject to the application is provided with this notice.

PURPOSE AND EFFECT: An application submitted by Reynolds Surveying on behalf of Alfred Cini, owner of the subject land. The application proposes to create one residential building lot for a total of two lots.

The portion of the property proposed to be severed as shown on the survey provided (Part B) has a frontage of approximately 15.92 metres (52 feet), a depth of approximately 50 metres (164 feet) and an area of approximately 1,082 square metres (11,647 square feet).

The portion of the property to be retained as shown on the survey provided (Part A) has a frontage of 15.29 metres (52 feet), a depth of approximately 50 metres (164 feet) and an area of approximately 1,357 square metres (14,607 square feet).

OTHER APPLICATIONS: The land subject to this application for consent is currently the subject of Deeming By-law DB01/19.



APPOINTMENT FOR HEARING: Monday, April 15, 2019 at 4:40 p.m. has been appointed by the Committee of Consent for the Town of Wasaga Beach for the purpose of a public hearing of all parties having an interest in this matter.
