The Development Services Committee reconvened at 11:20 a.m. for **Public Meeting – Town of Wasaga Beach –** Proposed General Amendment to Zoning By-law 2003-60, as amended, Section 3.18 – Street Requirement - Eastdale Drive/Coastline Drive.

GENERAL INFORMATION

PROPOSED AMENDMENT TO THE TOWN OF WASAGA BEACH COMPREHENSIVE ZONING BY-LAW 2003-60

Section 3.18 Street Requirement

Notice of Public Meeting was published in the Wasaga Sun Newspaper on January 17, 2019, and circulated to all agencies, service providers, school boards, and abutting municipalities as prescribed in the *Planning Act*. This provided 20 days of notice for the public meeting and this meeting is therefore properly constituted as required by the Planning Act.

THE PROPOSED ZONING BY-LAW AMENDMENT would add provisions to Section 3.18 Street Requirement of Zoning By-law 2003-60 to provide that despite Section 3.18, the construction of buildings or structures may occur on existing lots of record for properties that front onto the sand vehicular access lanes located adjacent to the Nottawasaga Bay and known as Coastline Drive and Eastdale Drive.

THE EFFECT of the proposed Zoning By-law Amendment would be to facilitate the expansion of existing dwellings or construction of new dwellings on existing lots of record that have access and 'frontage' from the sand vehicular access lanes known as Coastline Drive and Eastdale Drive.

As a result of the circulation of the Notice of Public Meeting the following written comments were received:

Letters of Support: None

Letters of No objection: Enbridge Gas

Letters of Concern: An email from the Nottawasaga Valley Conservation Authority on February

6, 2019 where in they advise against approval of the amendment stating concerns regarding natural hazards, safe accesses, high costs of engineering to develop, and conflicts with the town zoning by-law and NVCA

policy and procedures.

Letters of Objection: None

The Chair asked Ms. Jarratt if the Town received any further letters or correspondence in regard to this application. There were none.

Ms. Jarratt made a brief presentation and provided further details with respect to the proposed Zoning By-Law amendment.

Ms. Jarratt explained that residents fronting on Eastdale Drive and Coastline Drive are currently not able to obtain a building permit, because the properties don't meet the street requirement under Zoning By-law 2003-60. There have been building permit requests from property owners and the Town is not able to issue a building permit, only because the street requirement can't be met. Each individual property owner would have to come in for a site-specific zoning by-law amendment which is onerous for property owners.

The suggested amendment would allow the property owner the erection of a building or structure on a lot within a Residential Type 1 (R1) zone existing at the time of passing of this by-law and which abuts the vehicular

accesses known as Coastline Drive and EastdaleDrive, located adjacent to the Nottawasaga Bay, provided all other provisions of the zoning by-law are complied with.

The Chair asked if there was anyone present that would like to provide input either in support of, or in opposition to, the proposed amendment. If so, to please stand and clearly state your name and address in order that it may be correctly entered into the records of today's proceedings. There were no comments from the public.

The Chair asked members of Committee if they have any questions or comments with regard to the proposed amendment.

Councillor Watson commented that it is positive to see this zoning by-law amendment come forward and it would have a positive impact on the property values.

Councillor Belanger commented that this would be easier for residents and also possibly reduce the burden on staff. Mr. Herron confirmed that the principle for this change is that this particular clause has affected property owners and is onerous for the applicant.

Councillor Foster requested confirmation that road occupancy permit would be required and that those fees would reflect the amount of work required. Mr. Herron confirmed that a road occupancy permit would be required if the homeowner wanted to construct a new driveway.

Councillor Wells referred to the letter of concern received from the NVCA. He noted that there is a MOU between the NVCA and the Town, which defines the legislative authority and advisory role of the NVCA. Mr. Herron explained that the NVCA has regulatory authority over these properties and this is mapped. The NVCA did not advise what the concerns for these properties are and staff has not yet had the opportunity to discuss this with the NVCA.

Councillor Wells further noted that he is in full agreement with the proposed zoning by-law amendment. He noted he hopes that NVCA does not chose to become obstructive in this matter going forward.

Mayor Bifolchi suggested to direct staff to send a letter to the NVCA, requesting a response to why they are taking this standpoint.

Councillor Watson commented that there were approvals to put services into these properties and at that time there must have been NVCA involvement.

Comments received today will be considered and a decision will be made as to whether Committee will recommend the proposed amendment proceed further through the approvals process at a future meeting.
