

ADDENDUM Note

Please note that the **Council Agenda** has the following addendum to the for the meeting being held on **Aug 28, 2018**:

Section **11** of the agenda to be amended as follows, adding in the By-law with regards to the speed limit on Beach Drive as recommended by Coordinated Committee, stated in the minutes of the Public Works Section:

11. BY-LAWS AND CONFIRMATORY BY-LAW

- a) 2018-73 A By-law to establish and appoint a Joint Compliance Audit Committee.
- b) 2018-74 A By-law to prescribe and authorize the rates of speed within the Town of Wasaga Beach (Beach Drive, Spruce Street, 1st Street N., 2nd Street N., 3rd Street N.)
- c) 2018-75 A By-law to confirm the proceedings of the Council of the Corporation of the Town of Wasaga Beach at its Regular meeting held Tuesday, August 28, 2018.

THE CORPORATION OF THE TOWN OF WASAGA BEACH

BY-LAW NO. 2018- 74

A By-law to prescribe and authorize the rates of speed within the Town of Wasaga Beach (Beach Drive, Spruce Street, 1st Street N., 2nd Street N., 3rd Street N.)

WHEREAS Section 128 Subsection (2) of the *Highway Traffic Act*, R.S.O. 1990, chapter H.8, authorizes the council of a municipality by by-law to prescribe a rate of speed different from the rate set out in subsection (1) that is not greater than 100 kilometres per hour, for motor vehicles driven on any highway or portion of highway under its jurisdiction;

AND WHEREAS the Council of the Corporation of the Town of Wasaga Beach deems it necessary and expedient to reduce the speed of motor vehicles on certain highways within the Municipality;

NOW THEREFORE the Council of the Corporation of the Town of Wasaga Beach HEREBY ENACTS as follows:

1. THAT the speed of motor vehicles in the Town of Wasaga Beach in the designated areas outlined below shall be a maximum of 30 kilometers per hour as follows:

<u>HIGHWAY</u>	<u>FROM</u>	<u>TO</u>
Spruce Street	Main Street	Beach Drive
Beach Drive	Main Street	3 rd Street North
1 st Street North	Mosley Street	Beach Drive
2 nd Street North	Mosley Street	Beach Drive
3 rd Street North	Mosley Street	Beach Drive

2. THAT the definitions of terms such as speed, vehicle and other such terms referred to in this by-Law, shall be as per definitions applied in the *Highway Traffic Act* of the Province of Ontario.
3. THAT this By-Law shall come into force and take effect on the date of its final passing.

BY-LAW READ A FIRST, SECOND AND THIRD TIME AND FINALLY PASSED THIS 28th DAY OF AUGUST 2018.
