An Application for Consent to Sever has been submitted by MHBC (c/o Kory Chisholm), on behalf of DAS Development Corporation (c/o Denis Gubert), owner of the subject lands.

What is being proposed?

The application proposes to create one (1) new lot, for a total of two (2) lots.

The subject lands have a frontage of approximately 161.4 metres (529.52 ft.) along Daniela Drive, a frontage of approximately 89.3 metres (292.98 ft.) along Joseph Drive, and an area of approximately 14,517.4 square metres (156,263.99 sq. ft.).

The portion of the lands proposed to be severed, as shown on the severance sketch provided as 'Part 1' has a frontage of approximately 92.60 metres (303.80 ft.) along Daniela Drive, a depth of approximately 88.90 metres (291.66 ft.) and an area of approximately 8,320.5 square metres (89,561.11 sq. ft.).

The portion of the lands proposed to be retained, as shown on the severance sketch provided as 'Part 2' has a frontage of approximately 68.8 metres (225.72 ft.) along Daniela Drive, a frontage of approximately 89.3 metres (292.98 ft.) along Joseph Drive, and an area of approximately 6,196.9 square metres (66,702.87 sq. ft.).

OTHER APPLICATIONS: The lands subject to this application for Consent are currently subject to an application for Site Plan Control [Town File SP08/23] under the *Planning Act*.

The legal description of the subject lands is *NOTTAWASAGA CON 3 PT LOT 33 RP 51R32826 PT PART 1*
